USE OF DILATATION GUTTER AND DILATATION STRIP

DILATATION GUTTER

Installation example: hanging gutter with a developed width of up to 500 mm. The dilatation gutter shall be installed at spacing of 15 m. For outer corner and beginning of the gutter, a half of the standard value is applied: maximum 7,5 m. For inner corner, a quarter of the standard value is applied: maximum 3,75 m. For other materials and dimensions: see the table below. Corners are always taken into account as fixed points.

DILATATION STRIP

Indoor installation: on gutters attached without gluing to a substrate, roofs with non-standard profile and roof cladding




For outer corner or the beginning of the gutter, a half of the standard value shall be applied.



Note to the dilatation gutter mounting.

When mounting by soldering, first cover the middle rubber part with a wet cloth (to prevent heat transfer to the middle rubber part). A minimum distance of 6 cm from the middle rubber part must be kept. In any case avoid contact of rubber with open flame.



Note to the dilatation strip mounting.

When bending and mounting dilatation elements, make sure that:

- Bending jaws have a radius of at least 2 mm.
 For sheet metal thicknesses over 1 mm, it must be observed bending radius at least 5 mm.
- When bending, the bending jaws should be set to a thickness of the middle rubber part of 3 to 4 mm to prevent the cutting effect - damage to the rubber.
- The rubber middle part must not be compressed or damaged during bending. Therefore, an aluminium sheet strip 2 to 5 mm (thick) should be used, bent so that it can be attached as a protection to the bending jaws. This achieves a larger bending radius and prevents the rubber middle part from breaking.




